Original applications for VPB access should be signed and submitted in hard copy to the Office of the Clerk of Court, 1 Courthouse Way, Suite 2300, Boston, MA 02210.

A PACER (Public Access to Court Electronic Records) account also is required to access the Court's Electronic Filing System. PACER accounts may be obtained from the PACER Service Center at <a href="https://pacer.uscourts.gov">https://pacer.uscourts.gov</a>. You will need to submit a Non-Attorney Admission/E-File Registration through PACER which must be approved by court staff. PACER registration instructions can be found in the Virtual Press Box Guide.

After your application is approved, you may then access the system through PACER.
