GORTON, J.

1. Pursuant to Rule 42(a) of the Federal Rules of Civil Procedure, all direct purchaser actions currently centralized in this District and assigned to this Court,¹ and all subsequently-filed or transferred related direct purchaser actions, are hereby consolidated for pretrial purposes.

2. Pursuant to Rule 42(a) of the Federal Rules of Civil Procedure, all end-payor actions centralized in this District and assigned to this Court,² and all subsequently-filed or transferred related end-payor actions, are hereby consolidated for pretrial purposes.

3. The consolidated direct purchaser actions and the consolidated end-payor actions will not themselves be consolidated. Discovery and other pretrial proceedings in the two consolidated actions, however, will be coordinated to the extent reasonably practicable.

4. The direct purchaser plaintiffs and end-payor plaintiffs are directed to file their respective consolidated complaints within three (3) business days of this Order.
