For the payment of registry funds, criminal penalties and bail bonds, the Court will accept cash, checks, and money orders only. All fees are payable to the "Clerk, United States District Court."

The fee is currently 10 cents per page, not to exceed the fee for 30 pages for caserelated documents. Local, state, and federal government agencies will be exempted from the increase for three years, from April 1, 2012.
