LOCAL RULE 83.3(a): PHOTOGRAPHING, RECORDING AND BROADCASTING

Local Rule 83.3(a) provides: "Except as specifically provided in these rules or by order of the court, no person shall take any photograph, make any recording, or make any broadcast by any means, in the course of or in connection with any proceedings in this court, on any floor of any building on which proceedings of this court are or, in the regular course of the business of the court, may be held."

Violations of this rule may result in the suspension or revocation of the media credentials of an individual or media organization and the imposition of other sanctions upon court order.
