GENERAL ORDER SUPERSEDING PUBLIC NOTICE OF MARCH 12, 2020 (PUBLIC NOTICE)

SAYLOR, C.J.

This Order supersedes General Order 20-1 (Public Notice issued March 12, 2020) concerning entry to the Courthouse. Since the issuance of that Order, the Court has consulted with epidemiologists and public-health experts to determine appropriate protocols for the conducting of proceedings in the Courthouse. In accordance with that guidance, and consistent with the General Orders that the Court has adopted since March 12, 2020, including but not limited to General Order 20-31, adopted on July 15, 2020, the Court ORDERS as follows:

- 1. All persons entering the Courthouse and in the public spaces of the Courthouse, including the courtrooms, shall wear masks covering their nose and mouth. The only exceptions to that requirement are (a) for a witness testifying under oath, who will testify behind a clear acrylic barrier, or (b) where a judicial officer has made a specific temporary exception that the interest of justice, balanced against the public-health risk, requires such action for reasons provided on the record.
- 2. All visitors entering the Courthouse (including attorneys, witnesses, parties, or members of the general public) must conduct a health self-assessment in advance of entry. A link to that health self-assessment is set forth below.

3. A person may not enter the Courthouse if he or she:

a. has a diagnosis of COVID-19;

b. is experiencing any of the symptoms of COVID-19 identified in the health self-

assessment;

c. has been ordered by a public-health authority or medical professional to isolate or

quarantine due to COVID-19; or

d. to his or her knowledge, has been in "close contact" with someone with COVID-19.

For these purposes, "close contact" is defined as "being within 6 feet of for at least

10-15 minutes while symptomatic or within 48 hours before symptom onset."

If you have a scheduled appearance in the Courthouse and you may not enter for one of the

reasons listed above, you should contact the clerk of the appropriate session as soon as possible.
